#### 4. FIRST AID MEASURES

<b>Swallowed</b>	If swallowed, DO NOT induce vomiting or give anything by mouth. Seek immediate medical attention. Do not leave victim unattended. Vomiting may occur spontaneously. To prevent aspiration of swallowed product, lay victim on side with head lower than waist. If vomiting occurs and victim is conscious, give water to further dilute the chemical.
<b>Eye</b>	If dust enters the eyes, flush with plenty of water for at least 15 minutes, ensuring eye lids are held open. If irritation persists, transport to hospital or doctor.
<b>Skin</b>	In case of contact, immediately wash with plenty of soap and water.
<b>Inhaled</b>	If respiratory irritation or distress occurs, remove the victim to fresh air. Seek medical attention if respiratory irritation or distress continues. If breathing is difficult, give oxygen. If breathing has ceased apply artificial respiration using oxygen and a suitable mechanical device as a bag or mask.
<b>First Aid Facilities</b>	Eye wash fountain, safety shower and normal wash room facilities.
<b>Advice to Doctor</b>	All treatments should be based on observed signs and symptoms of distress in the patient.

#### 5. FIRE FIGHTING MEASURES

#### 6. ACCIDENTAL RELEASE MEASURES

#### 7. HANDLING AND STORAGE

Store in a cool place and out of direct sunlight. Store away from sources of heat or ignition. Store away from oxidizing agents. Keep containers closed, when not using the product. Store in original packages as approved by manufacturer. Use good hygiene practices when handling live organisms.

#### 8. EXPOSURE CONTROLS / PERSONAL PROTECTION

<b>Engineering Controls</b>	Where engineering controls are indicated by use conditions or a potential for excessive exposure exists, the following exposure techniques may be used to effectively minimize employee exposures.
<b>Eye Protection</b>	When engaged in activities where dry ingredients could contact the eye, wear safety glasses with shields or goggles. In extremely dusty environments and unpredictable environments, wear unvented or indirectly vented goggles to avoid eye irritation or injury.
<b>Skin Protection</b>	Skin contact should be minimized through use of gloves and suitable long sleeve clothing.
<b>Respiratory Protection</b>	Avoid actions that cause dust exposure to occur. Use local or general ventilation to control exposures below applicable exposure limits. NIOSH or MSHA approved particulate filter respirators should be used in the context of respiratory protection program meeting the requirements of the OSHA respiratory protection standard [29 CFR 1910.134] to control exposures when ventilation or other controls are inadequate or discomfort or irritation is experienced. Respirator and/or filter cartridge selection should be based on American National Standards Institute (ANSI) Standards Z88.2 Practices for Respiratory Protection.
<b>Ventilation</b>	Use local exhaust or general dilution ventilation to control exposure within applicable limits.
