4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

Skin Contact: If skin or hair contact occurs, immediately remove contaminated clothing and flush skin and hair with running water. Continue flushing with water until advised to stop by the Poisons Information Centre or a Doctor; or for 15 minutes and transport to Doctor or Hospital.

Eye contact: If in eyes, hold eyelids apart and flush the eyes continuously with running water. Continue flushing until advised to stop by the Poisons Information Centre or a Doctor; or for at least 15 minutes and transport to Doctor or Hospital.

6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

7. HANDLING AND STORAGE

TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight-hour workday.

'Sk' Notice - absorption through the skin may be a significant source of exposure. The exposure standard is invalidated if such contact should occur.

16. OTHER INFORMATION

Reason for issue: Revised

BioCidal comes in a concentrated version, this means that depending on the cleaning you want to do, Biocidal concentrate should be mixed with water. The BioCidal "5-1 Spray/Wipe Cleaning", has been formulated to have both cleaning / disinfectant properties based on the products used. Remember, a disinfectant is a substance that is used on hard or soft, non-living objects to kill microorganisms and is not intended for internal use or use on the skin. It is commonly accepted in the food industry that for food contact surfaces 200ppm quat with 10 minutes contact time will provide efficacy against Staphylococcus aureus and Enterobacter aerogenes.
